1. Call to Order and Quorum Determination- The meeting was called and a quorum of board members were present- Angi Grant, Anne Nolan, Max Chen, Dorcus Mukendi, Robbie Przepioski, Jeff Davis, and Lynn Sheridan-Merritt
2. Calendar/Upcoming Events
